12. IVSA activities, 16.19

Pim Polak, President, gave a presentation on the meetings he has attended on behalf of IVSA. Pim attended the International Pharmaceutical Students' Federation (IPSF) board meeting in January 2014 in The Hague, The Netherlands, where he presented IVSA and the one health concept, and signed the WHSS MoU. In March 2014, he attended the International Federation of Medical Students' Associations pre-GA and GA in Hammamed, Tunisia. IFMSA are the medical equivalent of IVSA, with whom we are currently working on strengthening our partnership. Also in March 2014, he attended the Student American Veterinary Medical Association (SAVMA) Symposium in Fort Collins, Colorado, USA, along with other IVSA representatives including James Bost, Secretary General and Vice-President, Hannah van Velzen, Sponsorship Director, and Joseph Lunt, Development Aid Director, who ran the Development Fund auction there. SAVMA are IVSA's largest MO, and their Symposium is a good place to spread awareness of IVSA and network. In April 2014, Pim attended the Federation of Veterinarians of Europe – Standing Committee of European Doctors (FVE-CPME) conference in Brussels, Belgium, to represent the voice of veterinary students. Pim represented IVSA at the World Veterinary Association – European Commission (WVA-EC) global webinar entitled “Veterinary Leadership: “Empowering tools for vets in the field of Animal Welfare”” in April, and in May, attended the 16th International Veterinary Medicine Students Scientific Research Conference in Istanbul, Turkey, as a speaker on IVSA and One Health. Also in May, he attended the European Association of Establishments for Veterinary Education (EAEVE) GA in Murcia, Spain, where he spoke on student involvement in research,, represented the voice of veterinary students at the IFMSA pre-World Health Assembly (pre-WHA) and WHA, represented IVSA at the World Organisation for Animal Health (OIE) GA in Paris, France, and attended the Informal Forum for International Student Organizations (IFISO) spring meeting in July in Utrecht, The Netherlands. 17. Bylaws amendment – The Secretariat and Regional Representation, 11.39

Charlotte Watkins, IVSA UK & Ireland, moved to insert the following sentences at the end of the “Secretariat – Structure” section...:

The Secretariat shall consist of up to five (5) “Regional Secretary” positions. The number of Regional Secretary positions and regions represented by each position shall be determined by the ExCo. The remaining positions shall be non-regional “Secretary” positions.

...and to insert the following sentence after the 1st sentence for the “Secretariat – Responsibilities” section...:

Regional Secretaries are responsible for communication between MOs and Regional Groups within their region and the ExCo.

...and to strike out the 4th and 7th sentences in the section “Secretariat – Nomination and Election” section and insert the following sentences in place of the current 7th sentence...:

To be eligible for a specific Regional Secretary position, a member must be a member of a MO from that region (eligibility to be determined by the ExCo). If, after nominations have closed, there are no nominees for a specific Regional Secretary position, nominations for that position shall be re-opened without this requirement. If there are still no nominations for a specific Regional Secretary position, the responsibilities of that position shall be distributed at the discretion of the ExCo and an additional non-regional Secretary position shall be available.

...and to strike out the 11th sentence in the section “Secretariat – Nomination and Election” and insert the following sentences in its place:

If there is one (1) nominee for a Regional Secretary position, the nominee will be elected without a vote. If there are as many, or up to two (2) fewer, nominees for non-regional Secretary positions as there are open positions, the nominees will be elected without a vote.

...and to strike out the 14th and 15th sentences in the section “Secretariat – Nomination and Election” and insert the following sentences in their place...:

Election of nominees for Regional Secretary positions shall be by simple majority. If no majority is achieved by any nominee for a position, the nominee who received the lowest number of votes shall be eliminated from the nomination for that position and another vote shall take place. This procedure is repeated until a

Election of nominees for non-regional Secretary positions shall be by plurality-at-large.

If the result of the vote is such that more than one (1) nominee from one country are to be elected to non-regional Secretary positions, the provisionally elected nomination from that country receiving the least number of votes shall be invalidated until only one (1) provisionally elected nominee from that country remains.

...and to replace the words "member of the Secretariat" in the section "Executive Committee – Nomination and Election – Nomination of the members of the ExCo" with "a non-regional Secretary position".

It was clarified that if adopted, this amendment would go into effect immediately.

A count having been ordered, the results were 25 votes cast in favour and 18 votes cast against. The motion was lost after debate with 58.1% of votes cast in favour (75% needed to pass amendments to the Bylaws).

The MAH-IVSA Scholarship & Travel Grant Program involves 50-100 Scholarship Fund places over two years. 28. Presentation of IVSA Activities, 21.51

Merel Rodenburg, IVSA SAVMA, gave a report on the work of the Animal Welfare Committee (AWC). The AWC in 2013-14 consisted of 11 members from around the world. Their work this year has included the creation of a Facebook page to share news, information and opportunities, attendance of congresses on animal welfare and sharing information acquired, and contacting various organizations who may collaborate with the AWC in the future. Those who are interested in animal welfare can join the AWC Facebook group.

Sara Wüeggertz, Chairman of SCoMTE, IVSA Denmark, gave a report on the work of the Standing Committee on Modern Technology in Education (SCoMTE). The work of SCoMTE in 2013-14 included creating a more visual partnership with WikiVet, working on the SCoMTE links library, creating more interest in and activity on the SCoMTE Facebook page and creating a network of local SCoMTE ambassadors.

Pim Polak, President, gave a presentation on one health and the founding of the Standing Committee on One Health (SCOH). Theofanis Liatis, Veterinary Public Health Director, Chairman of SCOH, gave a report on the work of SCOH. SCOH in 2013-14 consisted of 10 members. Their work this year has included the creation of email and social media pages, creation of an online library for SCOH's publications, creation of a network of Local Veterinary Public Health Officers (LoVPHOs), and running campaigns for World Rabies Day and Stop TB. SCOH collaborates with the International Pharmaceutical Students' Federation (IPSF), the International Federation of Medical Students' Associations (IFMSA), Stop TB and the Global Alliance for Rabies Control (GARC). Further activities have included running One Health Workshops, creating and publishing (in the IVSA newsletter) the Veterinary Public Health Journal (VPHJ), and promoting IVSA's involvement in the World Healthcare Students' Symposium (WHSS) 2015. For World Rabies Day 2014, SCOH has led IVSA's involvement in the GARC-IFMSA-IVSA "Global One Health Challenge".

The Trust has the right to “Call for Attention”, which needs to be addressed by the ExCo and Secretariat during the ExCo meeting following such a call. When a “Call for Attention” has not been resolved without reasoning after calling for it at least twice, the Trust may decide to bring the matter before the General Assembly.

Member Organization shall retain the status of full Member Organization, provided that at least one (1) of the local Member Organizations joining together has that status at the time of formation of the national Member Organization.

...and to insert the following sentence at the start of the “Membership – Rights – Allocation of Vote” section...:

Candidate Member Organizations shall not have the right to vote.

...and to insert the word “full” before the first four current appearances of the words “Member Organization(s)” in that section, and to insert “Any present full Member Organization may not be proxy to more than two (2) Member Organizations” after the first sentence of the second paragraph in that section so that the section would read...:

Each country shall be allocated two (2) votes which the delegates of each full Member Organization within the country may jointly cast as decided by the separate full Member Organizations from that country.

If any full Member Organization can not be present at the General Assembly they can delegate their right to vote to another full Member Organization by either informing the ExCo in written or electronic form or providing the proxy Member Organization with signed certification. Any present full member organization may not be proxy to more than two (2) Member Organizations. This certification shall not apply to voting in matters not included in the preliminary General Assembly agenda nor shall it apply to voting in elections of any kind.

...and to insert the following numbered points at the end of the section “Membership – Application for Membership – Member Organizations”:

5. *Once a Member Organization application is approved, they shall be granted the status of candidate Member Organization.*
6. *To attain the status of full Member Organization, a member of the candidate Member Organization must have attended at least one complete General Assembly in person. This can be the same General Assembly at which candidate Member Organization status was granted.*

74. Report from 62nd IVSA Symposium in Turkey, for approval, 13.33

Anıl Türer, IVSA Turkey, Istanbul, presented the report from the 62nd IVSA Symposium in Turkey, on behalf of IVSA Turkey, Ankara.

James Bost stated that the Symposium OC from IVS Turkey, Ankara, have not been fulfilling their obligations (paying the 10% surcharge on Symposium fees to the IVSA Central Fund) despite repeated reminders, and suggested that the GA take no further action now, but that this be considered an "official warning" that IVSA Turkey, Ankara's membership could be terminated at the 63rd IVSA Symposium if they should continue to not fulfill their obligations.

Lukas Huber, IVSA Austria, moved to approve the report from the 62nd IVSA Symposium in Turkey. This was adopted after debate.

The Chair clarified that the ExCo had communicated an official warning to the OC.

75. Nominations of 64th Symposium presentations and voting, 13.57

Yong Heon Lee, Taeun Ryan Kim and Kim Jung Ming, IVSA South Korea, presented IVSA South Korea's nomination for the 64th IVSA Symposium.

John Hao-Hun Wu and Henry Ta-Heng Huang, Secretary to the MOD, IVSA Taiwan, presented IVSA Taiwan's nomination for the 64th IVSA Symposium.

Evanthia Kolovou, IVSA Greece, Thessaly, and Panagiotis Galatsanos, IVSA Greece, Thessaloniki, presented the nomination for the 64th IVSA Symposium from IVSA Greece, Thessaloniki, and IVSA Greece, Thessaly.

A written ballot having been ordered, the results of the first round of voting were as follows:

IVSA Taiwan received 21 out of 52 votes cast (40.4%)

IVSA South Korea received 19 out of 52 votes cast (36.5%)

IVSA Greece, Thessaly and Thessaloniki, received 12 out of 52 votes cast (23.1%)

After the first round of voting for the hosts of the 64th IVSA Symposium, no majority was achieved by any
